Nancy says:

Passover is a Jewish religious holiday that occurs in the spring, often at the same time as Easter. The eight-day festival commemorates the liberation of the Israelites from Egyptian slavery. Observance of Passover includes certain rituals such as not eating anything with a leavening agent in it - bread, cookies, cake - and it is highlighted by two Seder meals that include wine, eating matzah and bitter herbs, and retelling the story of the Exodus from Egypt. At our Delightful Dining dinner, you will experience a Seder meal and enjoy many of my favorite family Passover recipes. I look forward to seeing you on April 9th.
