He knows that running will be his life. One of the obstacles he faces is that he is Tutsi while the government at the time is Hutu. To the moment he must run to save his life is a ten-year span in which his country is undone by the Hutu-Tutsi conflict. This book won the Barbara Kingsolver Bellwether Prize for Fiction. In February there will be more than twenty LOReads events, open to everyone, related to this book and its themes. Our AAUW branch will again host one of the events on Saturday, February 9th. The speaker at the February Branch meeting is a young man from Oregon who is now in Rwanda teaching music under a Peace Corp grant. He will share his experiences with us.
