## Squire's Scribblings

What do you say about AAUW?

Remember the elevator speech? You're supposed to be able to get out a brief summary statement about something in the time it takes for the elevator to get to your floor. This comes up frequently when people ask us about AAUW. Some people think it's a union group, others think an automobile association, but many just have no idea.

What do you say when people ask you about AAUW? "It's a wonderful organization of women working for women's rights," or "It's a fun group of women who belong to book groups." Both of those answers are in a way, correct.

The official AAUW mission statement is a little awkward to just toss out there: "We are dedicated to advancing equity for women and girls through advocacy, education, philanthropy and research." I like the additional statement: "Since our founding in 1881, AAUW members have examined and taken positions on the fundamental issues of the day - educational, social, economic, and political."  $\ensuremath{\mathsf{a}}$ 

We accomplish AAUW's mission in many ways. And with all of our great efforts, there is always room for improvement.

Advocacy: We held a first meeting to discuss issues for advocacy efforts, both with other groups, and in our community, and will be moving forward on those charges. Six of our members attended Lobby Day at the State Capitol. Many of us are "Two-minute Activists". There is still work to be done with our advocacy efforts.

Education: Our branch meetings offer education on the issues we believe in such as equal pay and Title IX. Some of our book groups read books on related topics. We support scholarships locally and nationally. Give us your ideas for educating our members and the public!

Philanthropy: Each year we raise funds to donate to our scholarship at Marylhurst University, and to provide funding for the "AAUW Funds" program nationally. You can go to https://www.aauw.org/what-we-do/educationalfunding-and-awards/ to see the kinds of programs, scholars, and legal support AAUW Funds supports. Consider donating!

Research: AAUW does research on a variety of different issues that the organization uses for education. Our first speaker of the year presented material from the AAUW report, "Deeper in Debt," a study on how student loan indebtedness affects women. 

As we look forward to our Friendship Tea, a little light reading, Sarah Rose's *For All the Tea in China*.



Through hands-on problem solving and encounters with women role models in science, technology, engineering, and math (STEM), AAUW Tech Trek helps girls see their futures while having nonstop fun. This one-week summer camp is backed by AAUW's research and designed to make STEM fields exciting and accessible to girls in middle school — the age when girls' participation in these fields statistically drops. For many girls, the weeklong camp sparks their curiosity and places them on a path toward success.



AAUW of California member Marie Wolbach founded Tech Trek in 1998 with the help of an AAUW Community Action Grant. Today AAUW Tech Trek operates at 22 different sites around the nation. A 2013 survey of AAUW Tech Trek alumnae from California demonstrates the program's lasting effects on many levels, including interest and confidence in STEM fields, decision to pursue those fields, and future career plans. ## Dues Update

Our National organization recently announced a \$10.00 increase in their portion of our annual membership dues. This brings their portion to \$59.00. All but \$3.00 of this amount is tax deductible. Branch and State dues remain at \$17.00 and \$16.00 respectively. This increase means that dues for the 2018-19 year will total \$92.00.

In a few weeks you will receive an email "invoice" from National reflecting this change. The best and most efficient way to pay is by credit card. The instructions are easy to follow. Paying in this way saves our branch money and our Board hours of work. The dues are divided appropriately and electronically deposited in the correct accounts. We strongly encourage you to renew in this way. Of course, we still accept checks!

If you are considering becoming a Life Member this is an ideal time to do so. The current one-time cost is \$980. After March 16th it will increase to \$1,180.

This membership category covers your National dues for your entire lifetime. Branch and State dues continue to be paid annually.
