Squire's Scribblings

What we learned on our convention weekend:

Ten branch members, equaling 10% of our membership, attended all or part of the AAUW State Convention in Hillsboro the weekend of April 20-22. It was a great experience for all of us. Our contingent ranged from long-time members to relatively new members. Conventions are held around the state and this is the first one in the Portland area in four years.

First, congratulations to Judy Hale, our past president and our state Program Co-Chair, for the great job with programs for this convention. The sessions were the best I've attended in five conventions. Judy, thanks and congratulations!

• Our College/University Partner Melody Rose, President of Marylhurst University, gave the keynote address Friday night and set the tone for the weekend. She talked about what it will take to get women elected, and specifically elected to high national office. Her talk was enlightening, encouraging in many respects, and cautionary in others.

- Susan Shea, attending her first convention, enjoyed the panel of women legislators, and appreciated their variety of backgrounds and ages. She is glad to know there are such impressive women acting on our behalf in Salem. (Oregon legislators panel moderated by Trish Garner.)
- "I particularly enjoyed the enthusiasm of Amy James Neel, who spoke about the Oregon Tradeswomen's groundbreaking program to prepare women for apprenticeships," says Jane Taft. (Oregon Tradeswomen, Inc., by Amy James Neel.)
- Susan Hornung appreciated the four young women representing different organizations which encourage and train women to run for office and also train women to staff and direct campaigns. (Mentoring the Next Generation for Public Office, moderated by Micki Varney, Salem branch.)
- Karen Rottink also enjoyed the same session as Susan. She was surprised that there are four separate organizations available in Oregon to assist women who want to run for public office. She also was impressed by the four legislators and their dedication, along with their many other obligations.
- Mary Pat Silveira, also a newcomer to convention, was impressed with the entire program. She liked the emphasis on advocacy of different issues, including sometimes overlooked stakeholders such as women veterans and tradeswomen.
- Marty Maharg, another first-timer, felt she learned a lot about AAUW and now has a better understanding of some of the organization's efforts. She (along with Mary Pat) was especially interested in the Saturday dinner speaker, Paul Thein, plaintiff in a Title IX case. He was a whistleblower at a junior college and was fired in retaliation. The AAUW Legal Advocacy Fund (LAF) supported him in his ten+ year effort to win his case against the state of California. (He did finally win.)

National AAUW Election

Your Vote Counts! National AAUW Election is Important to all of us!!!

AAUW is conducting a national election with three proposed bylaw amendments. The voting will be open from April 25-June 9, so there is plenty of time to educate yourself about the issues and cast your vote. You can vote electronically, after you receive the spring issue (again, electronically) of *Outlook Magazine*, complete with your own pin number, or you may request a paper ballot and cast your vote through the mail. By the time you receive this newsletter, you should have received an email from National about the bylaws.

Two of the amendments concern the national board make-up. One is with regard to staggered terms, which makes sense so that there is continuity on the board. The other is seeking to add potentially one-third of the board members who are not members of AAUW. This is proposed supposedly in order to seek expertise that may be outside of current AAUW board member candidates. This is a bit controversial, but it is a practice with some organizations. Perhaps the board recruitment group could look a little harder at national members who may also have the talents they seek.

The third amendment is one that has been raised often over the years. It is to eliminate the degree requirement for membership in AAUW. Simply stated, anyone could join. This same bylaw amendment was voted on in 2017 and defeated 60% to 40%, but the board says the vote again this year is to "clarify" that vote. The argument for this, is (1) that AAUW is a mission-based organization promoting equity for all women and girls; therefore, all should be able to be members, and (2) when seeking corporate and foundation gifts, the degree requirement will be seen as exclusionary.

On the other hand, AAUW has a strong reputation with elected officials because its membership is educated and informed. There are many other organizations with open memberships promoting women's causes, such as NOW, YWCA, and Planned

Parenthood. Many of our members joined because it is a women's organization for women who have a two-year associates degree or a college degree. And while it is important to seek diversity in funding from corporations and foundations, currently 70+% of revenue comes from member-related activity.

So, I know we all have strong feelings about this, and we heard many of those feelings expressed at the convention. Shannon Wolfe, the Managing Director of AAUW, who started at the organization in December 2017, stated that there is currently no plan to change the name of AAUW. She said if the bylaw changes pass, they will take effect on July 1 of this year.

There is a good case for both sides of this question. I urge you to talk in your interest groups, at our brunch in May, and with individuals in our branch that you want to seek out for discussion. The board, as listed on the front page of this newsletter, is willing and eager to talk with you about this. However, in the end, it is always your decision how you want to vote. I STRONGLY URGE YOU TO VOTE ON THESE BYLAWS!

Frequently asked questions:

When and how can I vote?

- All voting will take place online in spring 2018 unless a member sends a specific request to AAUW for a paper ballot.
- Vote online: Online voting is encouraged because it is fast, easy, secure and green! Online voting is open at 9 a.m. ET, April 25, 2018, and available through 9 p.m. ET, June 9, 2018. To vote online, you must use your member number and a PIN number. YOU SHOULD HAVE RECEIVED AN EMAIL ON APRIL 25 ENTITLED AAUW ELECTION. IT INCLUDES YOUR MEMBER NUMBER AND THE PIN THAT IS REQUIRED TO VOTE.
- Paper ballot: Paper ballots must be requested from AAUW between April 16 and May 7, 2018. No ballot will be issued if the request is received after May 7, 2018. All paper ballots mailed to AAUW

must be postmarked by 11:59 p.m., May 21, 2018, the deadline for the ballots to be scanned and counted. Paper ballots submitted after that date will not be counted. To request a paper ballot, email your name, address, and member number to connect@aauw.org or call 800.326.2289.

May 7, 2018:

Deadline for AAUW to receive request for paper ballot.

May 21, 2018:

Deadline for mailing paper ballot; ballot must be postmarked by 11:59 p.m. ET to be counted.

June 9, 2018:

Online voting ends at 9 p.m. ET.

June 10, 2018:

Vote results announced online.
