"We express our profound shock and disappointment about the events that took place on January 6, 2021, in Washington, D.C. and elsewhere. We also affirm our commitment to our democratic principles. Our country's democracy is undeniably imperfect, but it represents a worthy ideal. Violence in the name of a political point of view should not be tolerated."

The inauguration is in a scant 11 days, and we can only hope that this time will pass in peace and without harm to anyone.

We all need to consider the parts that we must play in protecting and nurturing our democracy. Certainly, taking our place as purveyors of the truth and as standard bearers of equal rights and justice is foremost.

# **Creation of Gender Policy Council**

On January 19, 2021 Kimberly Churches made the following statement:

"AAUW is thrilled to learn that the Biden-Harris Administration has created a White House Gender Policy Council, a team charged with implementing a 'government-wide focus on uplifting the rights of girls and women in the United States and around the world, restoring America as champion for women and girls..."

"The task they face is formidable: The pandemic has been devastating for women of color and crushing for women in general. Despite making up the majority of the nation's essential workers, women have disproportionately suffered from our country's inadequate response to the COVID-19 crisis, losing more jobs and taking on family responsibilities that drove many out of the workforce. The road to recovery will be long, but with this Council guiding the way in an intentional, coordinated fashion, we are confident we'll be swiftly traveling in the right direction."

# The Simple Truth About the Gender Pay Gap

A recent research report posted on the AAUW National Website, titled "The Simple Truth About the Gender Pay Gap" describes many current public policy challenges for women in 2021. Women working full time in the United States are paid 82 cents to every dollar earned by men – but it doesn't stop there. The consequences of this gap affect women throughout their lives. Though women now out-pace men in higher education, women also hold nearly two-thirds of the outstanding student debt in the United States. Because of the gender pay gap, it is harder for women to repay loans. The pay gap even follows women into retirement. As a result of lower lifetime earnings, they receive less in Social Security and pensions. In terms of overall retirement income, women have only 70% of what men do.
