Diversity, Equity, Inclusion Marty Maharg

November 24 is Thanksgiving. It is a time to give thanks for all we have and to help those less fortunate to feel cared for and included.

Although Indigenous Peoples' Day was October 11, this is a good time to remind ourselves that the Thanksgiving story we grew up with is a myth. The reality is that white Euro-Americans unjustly took indigenous peoples' land, their livelihoods and denied them rights.

The Fifteenth Amendment (1870) granted voting rights to all citizens. While some American Indians were given citizenship (Dawes Act 1887), it was not until the 1924 Snyder Act that granted full citizenship to all Native Americans. Unfortunately, it took another forty years and the passage of the 1965 Voting Rights Act to affirm enfranchisement in every state! American Indians have not had equal access to education, making it very difficult for them to succeed

professionally and financially. Recently, Oregon announced the Oregon Tribal Student Grant which provides financial assistance to students who are attending eligible Oregon public and private colleges, universities and community colleges during the 2022-2023 academic year. This is good news and one step toward promoting equity to Oregon's indigenous people. Hopefully, the Oregon State Legislature will this continue to fund this endeavor.
