At the November Branch meeting,
Stephanie Wagner's presentation
highlighted the historical development of
the Lake Oswego Sustainability Network
which continues to drive eco-healthy
policy choices for this community.
Coupled with the Oswego Lake
Watershed Council, these teams, using
a strategic approach to sustainability,
make Lake Oswego not just a beautiful
place to live but one that will continue to
grow and improve.

The biggest obstacle facing us is the dependence on fossil fuels. Seemingly small efforts add up to large changes when everyone contributes: carpooling, "bunching" errands, filling a re-usable container with drinking water rather than buying bottled water, transitioning to electric vehicles, choosing electric over gas-fueled appliances when possible. All plastic begins as a fossil fuel. The three "R's" – "Reduce, Reuse, Recycle" emphasize limiting purchases of goods made, or packaged with, petrochemicals.

During the November Board meeting a number of issues were discussed:

Our **membership** number fell this past year. We now have fifty-eight members and are looking for ways to increase Branch engagement. Please let us know if you have ideas for a new interest group.

Unpaid members will be removed from the email list.

Marty Maharg attended a **Diwali celebration** at West Linn High School, sponsored by diversity groups in Lake Oswego and West Linn. Diwali is the Hindu Festival of Lights celebrating "victory of light over darkness, good over evil, and knowledge over ignorance."

Diversity, Equity and Inclusion (DEI) also asks us to consider whether there are any obstacles in our branch which prevent members from fully participating. Please let us know if you feel there are practices, or meeting locations, etc. that make your participation difficult or uncomfortable.

Communication Plan: To improve efficiency, the board decided that future messages to membership need to be approved by the President and the Communications Chair only and not by the entire Executive Committee.

A **Google Drive** is being established as a repository for Board minutes and all relevant documents. Stephanie will set it up and provide training for its use.

An **ad hoc committee** of Charlene, Diana and Catharine will meet in December to begin reviewing other locations in Lake Oswego for our programs. With the loss of several members, the increased cost of Heritage House is not sustainable for us long term.

We will not meet in January at Heritage House because many will be involved in the Martin Luther King Jr. National Day of Service. The refund from this cancellation will be applied to an extended time for the Gala for set-up and clean-up.

Diversity, Equity, Inclusion Marty Maharg

On October 24, Diana Ricks, Sharron Noone, Pat Squire and Marty Maharg attended an Oregon State Diversity Committee meeting. Chairwoman Trish Gardner, discussed Diversity, Equity, Inclusivity and Belonging (DEIB) as it relates to the AAUW mission and goals and how local branches can incorporate DEIB into their activities.

Following the meeting the Lake Oswego attendees met with Catharine Hojem to specifically discuss the LO Branch. All agreed that Lake Oswego and West Linn, where most members live, are quite homogeneous. While the number of BIPOC and LGBTQ members of the branch may be small, there are several members with sensory deficits, orthopedic and medical problems. These also are DEIB concerns. The group concluded the Branch needs to be more sensitive and accommodating to promote feelings of inclusivity and belonging.

In addition, members need to be mindful of statements or attitudes associated with implicit bias or micro aggression that can cause one to feel uncomfortable. The Branch needs to discuss ways to address these issues so all members sincerely feel included. Finally, the group discussed "the elephant in the room." How can the National AAUW promote DEIB when AAUW is an exclusive organization, limiting membership to those who have a college degree, minimally either a Bachelors or Associate of Arts degree? Such an organization is not inclusive.

In the new year, the committee will take up the afore mentioned concerns. It welcomes your comments, suggestions and participation.

Public Policy

Oregon will be the first state in the nation to enshrine the right to affordable health care in its constitution. Measure 111 passed with nearly 50.7% of voters in favor and 49.3% of voters opposed, a margin of about 22,000 votes. It addresses the cost of medical care as a major cause of hunger and even homelessness.

The following is excerpted from the *Oregon Foodbank Newsletter*, October 11, 2022.

"Hunger on the Ballot: Affordable Healthcare (Measure 111)"

"Healthcare and hunger are directly connected. A lack of nutritious food can seriously harm our health – and high medical costs force impossible decisions between the food and care we need to thrive...Oregon Health Authority reports that medical debt contributes to at least 60% of bankruptcy filings in our state. Last year, 1 in 3 Oregonians reported that healthcare costs led to skipped medications, canceled doctor's appointments or other actions that are detrimental to our health. And we know that meals are often the first thing families cut back on when budgets are tight."
