# Pregnant Workers Fairness Act and the Pump Act

On December 22, 2022, in a seventythree to twenty-four bi-partisan vote, the Senate passed the Pregnant Workers Fairness Act (PWFA) and soon will become law.

This law will allow pregnant women to provide for their families without compromising their health or pregnancies thus providing a safer future for all workers. It is one step towards providing paid leave and other family-friendly policies that this country desperately needs.

### This law will:

- Give pregnant workers access to basic accommodations like carrying a water bottle and taking bathroom breaks.
- Clarify that is is unlawful to discriminate against pregnant workers by forcing them out of their jobs unnecessarily or denying them reasonable accommodations.
- Prohibit employers from retaliating against pregnant workers who request accommodations.
- Prohibit employers from withholding promotions and/or refusing to hire a person who is pregnant.
   Furthermore, a person is not required to tell an employer if she is pregnant.

Tucked into the PWFA is the separate Pump Act that expands protections for mothers who are nursing their babies. "Put together, these provisions are aimed at addressing holes in existing law that have allowed employers in the United States to force pregnant and nursing workers to choose between a

paycheck and their health, advocates say. The rules also come as the pandemic has forced employers, and the public, to reexamine how child care disproportionately affects working mothers, many of whom struggled to stay in their jobs or reenter the workforce since the pandemic upended the U.S. economy."<sup>1</sup>

To help pass these laws, AAUW advocates wrote countless letters to elected officials, met in-person with policymakers, rallied at the US Capitol and posted on social media. Gloria Blackwell, AAUW Chief Executive expressed her thanks "for all the ways you're [AAUW members] making a better world for women and girls. I am grateful beyond words." <sup>2</sup>

### **Public Policy**

Several new Oregon laws went into effect on January 1, 2023. Of particular note are the following:

Senate Bill 1574: Ensure Proper

Medical Forensic Care for Survivors of

SB 1574 ensures that that all evidence from the hospital exams are included in the SAFE Kit prior to transferring it to law enforcement.

House Bill 4002: Farm Worker Overtime Both state and federal law establish a maximum hour requirement of 40 hours per week and require employers pay one and one-half times the regular rate for all hours worked over 40 hours. However, agricultural workers were exempt from both the state and federal maximum hour requirement laws and therefore were not entitled to overtime pay. This inequity was accentuated by the intense manual labor, extreme heat and chemical exposure that farmworkers often face. HB 4002 remedies this inequity by phasing in overtime limits over several years, starting at 55 hours in 2023 and reaching 40 by 2027.

### Senate Bill 1586: Protections from Inappropriate Nondisclosure Agreements

The Legislature passed the Workplace Fairness Act (WFA) in 2019. Under the WFA, a private employer must adopt a written policy outlining procedures and practices for reducing and preventing discrimination and sexual assault. The WFA also prohibits employers from entering into a nondisclosure agreement

(NDA) as a condition of employment. It was brought to the attention of the Legislature that a loophole was being exploited that was effectively continuing the use of NDAs in inappropriate situations. SB 1586 closes this loophole. The law extends the prohibition regarding NDAs to cover former employees of private and public employers and clarifies that the prohibition covers current employees. The measure permits otherwise prohibited NDAs under specified circumstances and declares prohibited NDAs to be void and unenforceable.

Senate Bill 1515: Paid Family and Medical Leave Benefit Year Clarification In 2019, the legislature passed HB 2005, establishing a Paid Family Medical Leave Insurance Program providing employees with paid leave when they have medical issues, a new family member, or need safe leave. The current statutory language makes it difficult to identify a single paid year for workers with multiple employers. SB 1515 updates statutory language to create a single benefit year across employers.

House Bill 4113: Worker Compensation for Firefighters with Ovarian Cancer Oregon workers' compensation laws establish that certain cancers, including oral and male reproductive cancers, are presumed to be a compensable occupational disease for non-volunteer firefighters who have been on the job for at least five years. HB 4113 adds bladder and female reproductive cancers to this list.

### Senate Bill 1555: Universal Home Visiting Reimbursement

Senate Bill 526 established the Universal Home Visiting program in Oregon. Home Visit programs have shown positive impacts on reducing incidences of child abuse and neglect, improvement in birth outcomes, improvement in school readiness, and increased high school graduation rates for others who participate. SB 1555 clarifies the Oregon Health Authorities responsibility to support local newborn home visiting services and provide reimbursement for these services.

# House Bill 4031: Establishing Diversity Goals for Oregon Schools

To promote equality and representation in our schools, House Bill 4031 creates a goal to have the percentage of diverse employees employed by the Department of Education match the percentage of diverse students in our public schools.

### <u>House Bill 4133: Online Voter</u> Registration

Since 2010, Oregon has made it easy for citizens with a driver's license to register to vote online. Before the passage of HB 4133, eligible voters who did not possess a driver's license did not have access to this method of online registration. This bill makes it easier for Oregonians who do not have a driver's license to register to vote online.

# AAUW Funds molly divine

Your contributions to the AAUW Fund help advance gender equity for women and girls through research, education and advocacy not only in the United States but also throughout the world.

AAUW's CEO Gloria Blackwell and her staff participate in many organizations and activities, a few of which are the White House Gender Policy Council weekly call, the United Nations entity for Gender Equality and the Empowerment of Women, White House Equal Pay Summit with President and Mrs. Biden, and Speaker Pelosi's Women's History Month Celebration. Additionally, their research papers are used to inform members and to back up AAUW's lobbying efforts.

In 2022, members of the Lake Oswego branch donated \$785 directly to AAUW Greatest Needs Fund, and the Lake Oswego branch contributed \$1,000, for a total of \$1,785.
