Jennifer Vernon

The Lake Oswego Branch provided a scholarship in the spring of 2023 to the Early Childhood Education program at Portland Community College. We are fortunate to have their faculty spokesperson, Jennifer Vernon, M.S., as our first program presenter of the year.

Ms. Vernon received her Master's in Curriculum & Instruction from Portland State. She has been working at Portland Community College since 2015, first as an adjunct professor and then becoming full-time in 2019. Previously she worked for twenty years at Clark College in Vancouver, Washington in a variety of positions. As a beneficiary of scholarships from two non-profits herself, Jennifer is keenly aware of how life-changing this type of support can be.

Jennifer is emphatic about the need to maximize our instruction to the youngest ages, 0-5, where research shows they are most receptive to learning language and the acquisition of skills. Missing those opportunities can have a lifelong impact on a child's overall development. A collaborative approach using parents, family, and classroom experience to enhance learning has been shown to be very effective. As she states "Parents are always the first teachers and home is the first classroom".

Jennifer credits some of her passion for more of a systems approach in education to her own experience. She was born in Oahu, Hawaii, and attended a school focused on parental and community participation. The community members helped to determine curricula as well as then assisting with instruction. "Tutus" (grandmothers), would come in and teach language in addition to other culture-supporting skills.

In her presentation, Jennifer will speak about:

- PCC's program and the accreditation they've received from the National Association for the Education of Young Children (NAEYC)
- Covid and its significant impact on early childhood learning
- · the receipt of an ECE grant for a bilingual degree and certification program
- · childcare "deserts" and how programs such as theirs are creating solutions, and
- the numerous job prospects available to their program graduates

We look forward to learning more about this remarkable program we are fortunate to be supporting.

First introduced as a motion in 1971 by House Representative, Bella Abzug, and formally adopted in 1973, this is the day that celebrates and honors the women's suffrage movement and acknowledges the hurdles that women have had to overcome in their stride towards equality and progress.

Equal Rights Amendment (ERA)

AAUW National is supporting action by the current Congress to affirm the Equal Rights Amendment (ERA). The supported option is House Joint Resolution 25. This resolution would remove the arbitrary deadline for ratification and therefore recognize that the ERA has been ratified by the legislatures of \(^3\)4 of the states. This would allow Nevada, Illinois, and Virginia to count towards ratification, thus passing the threshold to recognize the ERA as part of the Constitution. This bipartisan resolution currently has 202 co-sponsors. A discharge petition for HJR 25 was filed on July 19th. A discharge petition is a procedural rule that enables the minority party in Congress to force a vote on an issue without a report from the committee by "discharging" the committee from further consideration of a bill or resolution. A discharge petition must gain 218 signatures to advance.



TAKE ACTION NOW: National has sent a list of representatives for members to contact to urge support

for both the discharge petition and the resolution. Representative Lori Chavez-DeRemer (Oregon's 5th congressional district) is on the list. As many of our members are her constituents I am encouraging those members to write to the representative asking her to support both the discharge petition and the resolution. Which of the 2023 Bills supported by AAUW of Oregon became Law?

AAUW of Oregon Public Policy Committee

Signed by the Governor:

- Senate Bill (SB) 599 requires landlords to allow childcare facilities to be located in rental properties. The companion bill HB 2468 authorizes the Early Learning Council to adopt reasonable requirements for landlords of tenants who operate a certified family childcare home in tenant's dwelling.
- SB 519 calls for expungement (deleting) of juvenile court records if requested.
- SB 424 prohibits post-secondary institutions from withholding transcripts from students who have outstanding bills due to the institution.
- House Bill (HB) 2002 established reproductive rights and gender-affirming care as it was prior to Roe v. Wade being overturned.
- HB 2535 calls for doulas to be available pre- and post-birth to pregnant women inmates at Coffee Creek Correctional Facility.
- HB 3005 provides financial assistance to eligible applicants to pay for costs related to early childcare infrastructure activities.
- HB 2727 calls for a work group to examine strategies for expanding early learning and care facilities in this state.
